## SUPPLEMENTARY APPROPRIATION 2019-20

## **O**VERVIEW

Supplementary Appropriation Bill (No.5) 2019-20 recognises additional Government revenue of \$17.1 million in 2019-20 and \$17.1 million in expenditures is appropriated for 2019-20, leaving a surplus balance of \$59.7 thousand.

This Bill reflects the outcomes of the mid-year review of budget estimates. It takes account of revenue received to date and expected to be received over the rest of the budget year. It also includes expenditure measures to support Government priorities.

The revenue estimate for general budget support is reduced by \$2.3 million, as payments previously expected from the Government of Taiwan into the Treasury Fund are to be redirected to other purposes, including to cover loan repayments to Exim Bank on behalf of Ronphos.

\$15.6 million dollars is allocated to Finance - Other payments. This includes provision for:

- \$5.1 million for Nauru Airlines to support the purchase of new aircraft;
- \$2.5 million for Nauru Rehabilitation Corporation to commence a pilot rehabilitation project for residential housing on government leased land;
- \$3.0 million to cover unexpected Government of Nauru 'in kind' Port Project costs;
- \$3.2 million for the fiscal cash buffer;
- \$1.7 million for the Nauru Trust Fund; and
- \$100 thousand for Cenpac to support it to take up the role of internet service provider at the Regional Processing Centre.
