# SUPPLEMENTARY APPROPRIATION 2019-20

### **OVERVIEW**

Supplementary Appropriation Bill (No. 3) 2019-20 recognises additional Government windfall revenue of \$56.9 million in 2019-20 and \$56.7 million in expenditures is appropriated for 2019-20, leaving a surplus balance of \$279.5 thousand.

In August 2019, the governments of Nauru and Australia, agreed the 2019-20 management arrangements for the Regional Processing Centre (RPC) on Nauru. The impact of these new arrangements has been an increase in hosting and service fees paid to Government, and a boost in business activity beyond what was planned at budget time.

The windfall revenue has provided an opportunity for the newly elected Government to fund its expenditure priorities, address urgent and unavoidable investment in key infrastructure, including community housing; support State Owned Enterprises (SOEs) to operate effectively, including addressing outstanding debt arrears; and to share some of the windfall revenue from the new RPC management agreement with government employees and those on pensions or living with a disability.

Overall this Supplementary Appropriation recognises the additional revenue and provides for expenditures that have arisen since the original budget. With the passing of this Bill the budget remains in surplus balance for the financial year.

\$162 thousand is provided to support a change in the birth allowance to \$600 for an unemployed mother and \$300 for an employed one.

\$13.8 million is provided as a subsidy to SOEs, mainly to reflect payment of debt arrears owed by Ronphos and Egigu Holdings Corporation to other SOEs, cash flow support for Ronphos and payment to NUC for prior year electricity consumption debt arrears owed by departments. Funding is also provided for Egigu to invest in new refrigeration equipment.

Provision is made for tug hire and purchase of a new jaw crusher for NRC to support the provision of aggregate for the new Port project.

Funding is also provided to finalise the establishment of the Port Authority of Nauru, including to cover the costs of new staff and to meet Government of Nauru in kind contributions to the Port project.

\$2 million is provided to undertake maintenance on fuel tanks and \$180 thousand is provided for consultancies to provide advice to Government on SOEs and fuel issues.

\$5.7 million is set aside for the Nauru Trust Fund, \$6.2 million is allocated to the fiscal cash buffer, and \$1 million has been provided to pay Bank of Nauru depositors. Building and structures is replenished following an earlier decision to fund the 19 per cent ex gratia payment from this line.
