SUPPLEMENTARY APPROPRIATION No.1 2021-22

OVERVIEW

Supplementary Appropriation Bill (No.1) 2021-22 recognises additional Government revenue of \$32.1 million, and \$32.1 million in expenditure, with a small surplus balance of \$0.03 million.

This will bring total expected revenue for 2021-22 to \$276.3 million, and \$276.1 million is appropriated for expenditure, leaving a surplus balance for the year of \$0.1 million.

This Bill reflects updated revenue and expenditure estimates to take account of:

- hosting fee revenue and balance of RPC transition funds not recognised in the original budget
- government priorities and new commitments since start of the financial year

\$11 million in additional revenue is recognised to reflect the balance of the Transition Funds in the Commercial Operations and Services Fund. \$15 million was agreed and paid by the Government of Australia to facilitate the RPC transition, \$4 million has been utilised leaving a balance of \$11 million.

\$21.1 million in revenue is recognised to reflect the proposal to draw down an additional four months of hosting fee from the Commercial Operations and Services Fund.

\$4.9 million is provided for the Nauru Community Housing scheme to address overcrowding and sanitation issues.

\$153 thousand is provided to Chief Sec Administration Division for a new security arrangement for the IHMS hospital now taken over by RON Hospital.

\$50 thousand is provided to cover for a whole of government car rental arrangement to be managed by Chief Secretary Administration section.

\$355 thousand is provided for a three-day additional pay to civil servants to facilitate a government wide transition to full arrears payroll.

\$407 thousand is provided to support Nauru Shipping Line cover demurrage costs for Papa Mau following a government a decision to return the ship to Fiji following positive COVID 19 tests of the crew.

\$45 thousand is provided to help cover funeral costs for Nauruan nationals who pass away overseas. A fixed amount of \$15 thousand per death has been allocated and will be paid if a family wishes to repatriate the body of their loved one for burial in Nauru, covering embalming, repatriation, hospital fees etc.

\$4 million is provided to cover additional costs for the development of the Government owned land at Portion 230. \$5 million dollars was provided in the original budget to complete 5 hectares for which work is currently ongoing and this additional provision is to enable NRC to complete works for the remaining 4.82 hectares by July 2022.

- \$1.4 million is provided to facilitate settlement of additional Bank of Nauru debts to account holders that have valid bank accounts.
- \$5.8 million is provided to the Nauru Phosphate Royalties Trust for an additional Ronwan capital distribution, bringing the total allocation for the year to \$11.6 million. The funding comes from balances available from the Bank of Nauru liquidation.
- \$3.2 million is provided for a bonus contribution to the Nauru Inter-generational Trust Fund, providing for 10.1 percent of total revenue recognised in this supplementary.
- \$5.4 million is the reduced contribution to the Fiscal Cash Buffer to fund the increase in expenditure in this supplementary.

\$315 thousand is provided for 3 freight charters to contribute to the costs of maintaining transport connectivity and ensuring food security on island due to the return of Papa Mau.
