## PART I: EXECUTIVE SUMMARY

The Development Fund Annual Projections have been prepared as a separate budget document following the enactment of the *Development Fund Act 2011*. The Development Fund was established for the purpose of facilitating the funding of development projects.

The government anticipates that project-related cash grants paid into the Development Fund and subsequent expenditure will total \$14.3 million in FY 2022-23 (including \$9.2 million carried over from FY 2021-22).

Direct-budget support has increased by \$151,140 since last financial year. Cash-Funded support is projected to be **\$5.1 million** in FY 2022-23 - an increase of **\$2.6 million** from FY 2021-2, due to increases in funding by Taiwan, Japan, and the United Nations. Aid In-Kind has is estimated at **\$61.6 million** in FY 2022-23. This is a decrease of \$19.1 million, as investment in the Port redevelopment project winds down compared to previous years.

Total new support in FY 2022-23, including all financial and non-financial assistance, is estimated at **\$87.5 million**.

## PART II: DEVELOPMENT FUND ANNUAL PROJECTIONS

This document complies with Section 6 of the *Development Fund Act 2011*, which requires the Minister for Finance to table development fund projections in Parliament, consisting of anticipated development income and expenditure for the next financial year.

### OVERVIEW

The government expects the Development Fund to receive a total income of **\$14,296,740** and have a corresponding total expenditure of **\$14,296,740**, inclusive of unspent funds of \$9,221,283 carried over from FY 2021-22. This money is received in cash to the Republic, and paid directly into Development Fund accounts.

Additional assistance is also provided in the form of “In-Kind” support for projects that are funded by development partners for the benefit of Nauru. These Aid-In-Kind amounts are not paid into the Development Fund.

It is estimated that this in-kind assistance is valued at approximately **\$61.6 million** for FY 2022-23. An example of Aid In-Kind support from donors is the cost of consultants or advisers currently working in Nauru that are paid for directly by donors. The projected development assistance from Nauru’s major donors for FY 2022-23 is depicted in Table 2.2 below. It is anticipated that all projected funds will be expended in the financial year.

Total funding has decreased by \$15.5 million this financial year.

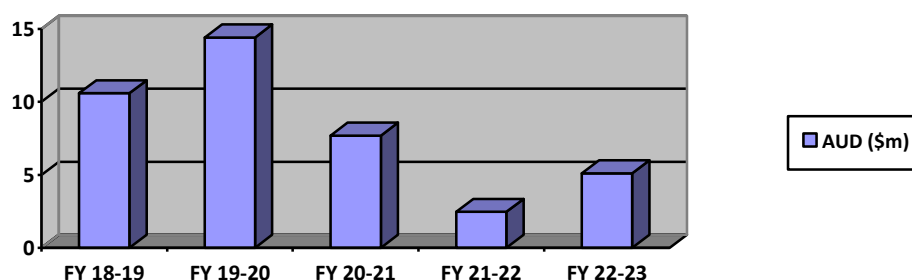
Aid In-Kind is \$19.1 million lower this financial year. This is primarily because the majority of funds for the Port Redevelopment Project have been received in previous financial years. Other factors contributing to the reduction include Australia reducing the Aid In-Kind support provided through the Partnership for Recovery: Australia's COVID-19 Development Response program and Taiwan's funding package excluding Taiwan-Nauru Partnership support this financial year.

Budget Support has increased due to a slight rise in Taiwan's cash support this financial year.

Cash-Funded development increased due to an additional \$15,000 in funding from Japan and an additional \$2.6 million from the United Nations.

The trend of direct cash projections over the last four financial years is depicted in Chart 2.1. Cash-Funded support has increased from \$2.6 million in FY 2021-22 to \$5.1 million in FY 2022-23. Cash-Funded development is now increasing towards FY 2020-21 levels, as donors recover from the impact of the COVID-19 pandemic.

## DONOR INVESTMENT TRENDS FY 2018-19 TO FY 2022-23

Donor investment trends over the past five years are shown in Table 2.4 and Chart 2.2 below.

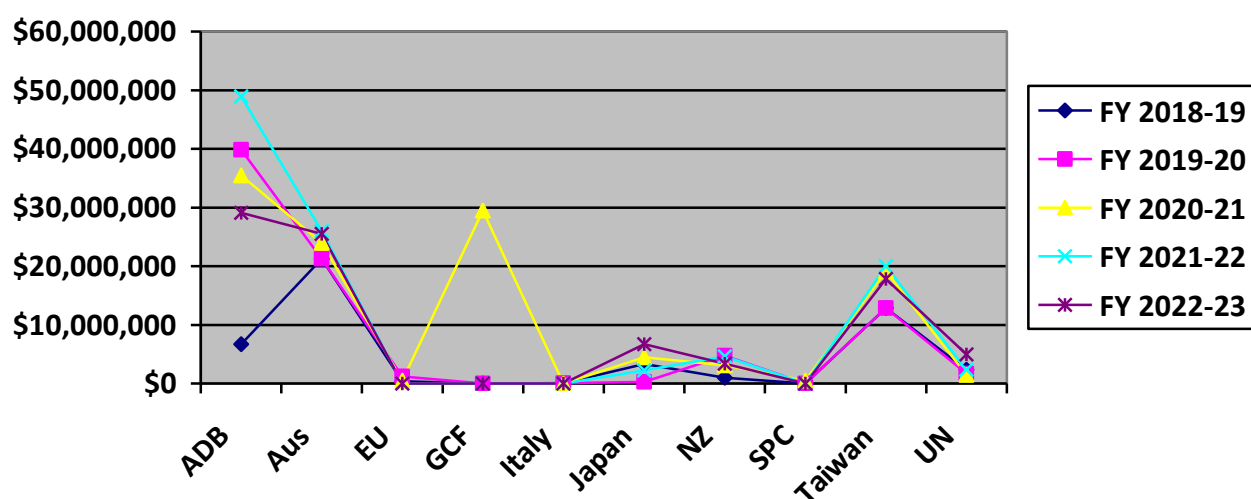

Australia's support has remained steady, at an average of \$23.6 million. There is a slight reduction of \$500,000 in support this year, as a result of programming for the Public Policy Strengthening project being unconfirmed upon development of this projection.

New Zealand's commitment has now settled on an average of \$4 million from FY 2019-20 to FY 2022-23, after a lower level of investment in FY 2018-19.

Japan's support has increased by \$4.5 million, primarily due to a large increase in the Economic and Social Development Program. The United Nations' support has substantially increased from previous levels, increasing from an average of \$2 million between FY 2018-19 to FY 2021-22 to \$5 million this financial year. ADB's commitment has markedly increased after FY 2018-19, due to support for the Solar project in FY 2019-20 and then the Port project in FY 2020-21 and FY 2021-22. However, support this FY has decreased as funding for the Port project has largely been provided in previous years.

Taiwan's investment has substantially increased from FY 2018-19 and FY 2019-20 levels, from an average of \$12.8 million to an average of \$19 million for FY 2020-21 to FY 2022-23. However, support decreased slightly from FY 21-22 levels due to a decrease in Taiwan-Nauru Partnership Support.

The EU consistently provided a moderate level of support between FY 2018-19 to FY 2020-21.

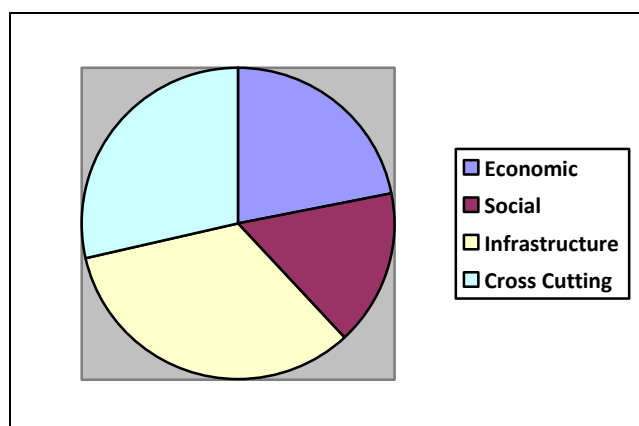
Non-traditional partner donations during the five-year period include Green Climate Fund investment in the Port redevelopment project in FY 2020-21, investment by Italy in a Household Water Storage project in FY 2018-19 and FY 2019-20, and a donation by SPC FY 20-21 for the Global Climate Change Alliance Plus Scaling up Pacific Adaptation (GCCA+ SUPA). This climate change adaptation and resilience project involved procurement of household water tanks, repair and installation of rain catchment systems in private homes.

As the Tables 1.1, 1.2 and Chart 1.1. illustrate, the Infrastructure Sector receives the most funding in FY 2022-23, at \$29.4 million. This is a substantial increase of \$21.6 million from last year's total of \$7.8 million. The increase is due to the additional funding for the Airport runway resurfacing from Australia, extra funding for the Solar and Nauru Sustainable Urban Development Projects from ADB, and increased funding for the Nauru Renewable Energy Initiative from New Zealand. Other new sources of funding compared to financial year 2021-22 include bilateral assistance in Energy Efficiency and Renewable Energy from the EU, and Taiwan's support for CENPAC ICT equipment.

The Cross-cutting sector receives the second largest amount of funding this financial year, with \$24.9 million in funding. However, this sector records the most significant fall in funding, down \$33.2 million from last year's total of \$58.1 million. This is mainly due to changes in classification of funding from last financial year, and a reduction in unprogrammed *Partnership for Recovery: Australia's COVID-19 Development response* funding from Australia.

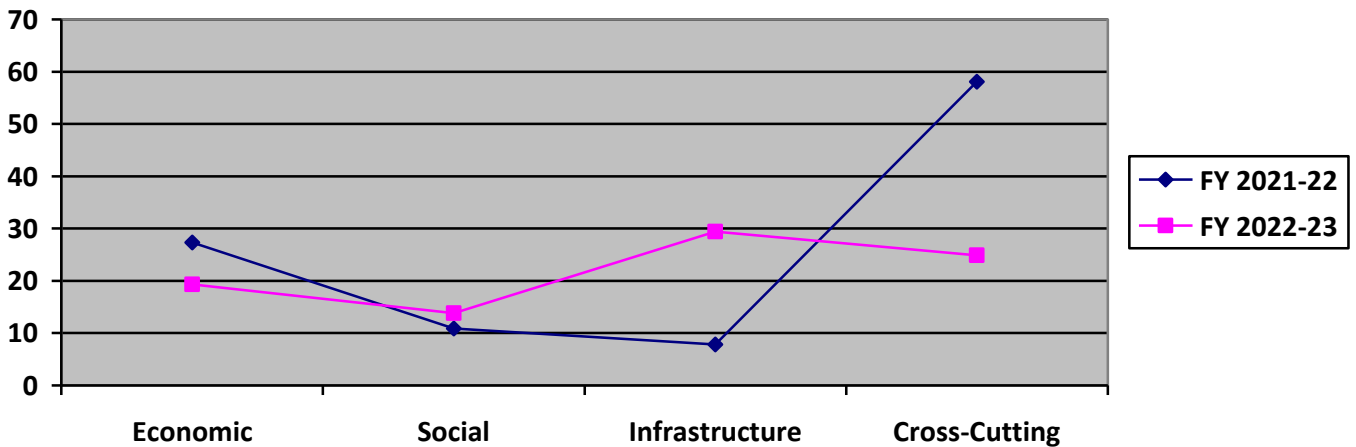
The Economic sector receives the third largest portion of development funding in financial year 2022-23, at \$19.3 million. Funding to this sector decreased by \$8 million from last financial year, reflecting a slight decrease in Intergenerational fund support from New Zealand. The exclusion of the Taiwan-Nauru Partnership support this financial year is also a factor.

Finally, the Social sector receives the smallest amount of funding this financial year, with \$13.8 million in support. This represents an increase of \$2.9 million from last financial year, which is mainly the result of improved clarity of UN programming.

### SUSTAINABLE & CLIMATE RESILIENT CONNECTIVITY PROJECT

The Sustainable and Climate Resilient Connectivity Project, which will redevelop Nauru's Port, was approved by ADB in August 2018 for USD \$62.3 million (AUD \$91.6 million), inclusive of co-financing from Australia and the Green Climate Fund. In FY 2022-23, a total of approximately **AUD \$9.6 million** will be provided for construction costs, reimbursement of the temporary relocation activities, and supervision consultant contracts.

### IMPROVED FISCAL SUSTAINABILITY AND SOCIAL PROTECTION PROGRAM (PUBLIC POLICY STRENGTHENING)

The proposed Improved Fiscal Sustainability and Social Protection Program involves a set of mutually agreed policy actions, which once achieved, triggers a AUD \$6.5 million (USD \$5 million) grant to be received as Budget Support. Policy areas of focus include debt management, state-owned enterprise reform, and support to vulnerable people. For FY 2022-23, ADB is expecting to contribute the full **AUD \$6.5 million** as direct Budget Support, including a contribution of \$1.2 million from New Zealand.

### SOLAR POWER DEVELOPMENT PROJECT

The Solar Power Development Project involves the instalment of a 6MW solar energy farm with battery energy storage system including institutional capacity development and was approved by ADB in September 2019 with a total budget of AUD \$32.3 million (USD \$22 million). For FY 2022-23, ADB is expecting to contribute **AUD \$11.5 million** in-kind assistance towards this project for construction, construction oversight, and other activities. The project is due to be completed by mid-2023.

### NAURU SUSTAINABLE URBAN DEVELOPMENT PROJECT

The Nauru Sustainable Urban Development Project will identify opportunities to improve water supply, sanitation and solid waste management on Nauru.

During this preparatory period, ADB will finance consulting inputs, institutional reforms, capacity building, and other activities to design and undertake due diligence work for the project.

For FY 2022-23, ADB is expecting to contribute **\$1.5 million** in-kind assistance for this project.

Australia continues to be one of Nauru's major donor partners with an expected **\$25.5 million** for FY 2022-23. Typically, Australia's donations include a higher level of Cash-Funded projects. However, this financial year the funding is represented as Aid In-Kind proposals agreed under *Partnership for Recovery: Australia's COVID19 Development Response*.

### PARTNERSHIP FOR RECOVERY: AUSTRALIA'S COVID-19 DEVELOPMENT RESPONSE

Australia will partner with Nauru on a range of programs to strengthen its resilience and work toward regional prosperity in sectors including economic reform, law and order, food security and transport connectivity priorities. Australia will also help the Government of Nauru support women and children in need, work closely with the Government of Nauru's gender mainstreaming unit and undertake activities to foster long-term economic recovery.

Australia will provide **\$7.5 million** Aid In-Kind under this partnership program.

### EDUCATION

Australia will implement a new Education program in financial year 2022-23. The new program will focus on improving student enrolment and attendance, improving learning outcomes and strengthening systems in the Ministry of Education. **\$4 million** of Aid In-Kind assistance will be provided for this program in FY 2022-23.

Australia will also continue support Nauruan tertiary scholarships in 2022-23. Around 55 Nauruan students were studying in Australia and the Pacific at the start of FY 2021-22. Australia's scholarship support is estimated at **\$1.5 million** in financial year 2022-23.

### HEALTH

Australia will support Nauru's broader health plans, including funding technical experts and key personnel in the Ministry of Health and infrastructure. Total estimated in-kind support to the health sector in this financial year is **\$5 million**.

### RUNWAY RESURFACING

Australia commenced a project to resurface the airstrip at Nauru airport. The total project value is estimated at \$40 million from 2022-23. The bulk of the funding will come from the Australian Infrastructure Financing Facility for the Pacific, while the bilateral program will contribute AUD 10 million over three years. **\$3 million** will be provided in financial year 2022-23.

**NAURU INTERGENERATIONAL TRUST FUND**

As a member of the Trust Fund Committee, Australia will make a contribution of at least **\$2.5 million** to the Nauru Intergenerational Trust Fund this financial year. The Nauru Trust Fund continues to be a mutual priority and an important mechanism to support Nauru's economic sustainability, positioning Nauru to access dividends to manage future economic transitions. Mitigating short-term investment losses through Australia's continued annual replenishments remains critical.

**PUBLIC SECTOR MANAGEMENT**

Public sector management support is mostly supplied through the Building Pacific Capability (BPaC) program, whereby Australia responds to Nauru requests for technical assistance. Technical assistance is supplied in support of the Department of Finance, but some is also provided to the Nauru Utilities Corporation, Education and Health Departments. Support through this modality is estimated at **\$2 million** in FY 2022-23.

### THE ECONOMIC & SOCIAL DEVELOPMENT PROGRAM (ESDP)

The Economic & Social Development Program (ESDP) is a type of assistance intended to support Nauru by promoting its economic and social development efforts inclusive of poverty reduction. ESDP provides foreign currency for import of goods as Aid In-Kind. Procurement for Excavators and Dump Trucks (approximately **AUD \$2.8 million**) is continuing for financial year 2022-23 ESDP to support the Nauru Rehabilitation Corporation to address the Higher Ground initiative. Procurement of Medical Equipment (approximately **AUD \$1.3 million**) is also continuing for financial year 2022-23 for ESDP to assist the Ministry of Health and Medical Services. A separate ESDP was signed in August 2021 and is ongoing for the procurement of heavy machinery (**AUD \$2.5 million**) to enhance waste management services. Another ESDP relative to undersea cable is expected in this financial year, but details have not yet been confirmed.

### GRANT ASSISTANCE FOR GRASS-ROOTS AND HUMAN SECURITY PROJECTS (GGP)

Grant Assistance for Grass-Roots and Human Security Projects (GGP) is intended to address the grassroots level with total **AUD \$125,000** to fund a future project. The Embassy of Japan has to conduct an on-site inspection to prepare a new project, but this visit was postponed due to COVID-19 travel restrictions.

### NAURU ENERGY EFFICIENCY - NAURU ENERGY EFFICIENCY ON THE DEMAND SIDE (NEEDS) PROJECT

The Nauru Energy Efficiency on the Demand Side (NEEDS) project Grant Funding Agreement (GFA) was signed in December 2020, and is funded by the Ministry of Foreign Affairs and Trade (MFAT) of the Government of New Zealand. The aim is to support the achievement of the 30% energy efficiency target set in the Nauru Energy Road Map (NERM). The project is now in the implementation phase. NEEDS project funding of **AUD \$1.7 million** (NZD \$1.8 million) will be provided in financial year 2022-23.

### NAURU INTERGENERATIONAL TRUST FUND

New Zealand will make a contribution of **AUD \$854,701** (NZD \$1 million) to the Nauru Intergeneration Trust Fund for the financial year 2022-23, as a member of the Trust Fund Committee.

### NAURU INCLUSIVE POLITICAL PROCESSES

New Zealand is expected to contribute **AUD \$721,362** (NZD \$843,993) towards the UNDP Nauru Accountable and Inclusive Governance (NAIG) Project for the financial year 2022-23. This activity builds on the UNDP's Phase One of electoral strengthening support in financial years 2018-2020, particularly electoral strengthening and women's political empowerment. The program will focus on and parliamentary autonomy and sustainability through institutionalising knowledge (for example, civic education and research on women's political empowerment).

### NAURU PRIVATE SECTOR ROADMAP IMPLEMENTATION

New Zealand will provide **\$256,410 AUD** (\$300,000 NZD) funding to the Australian Business Volunteers (ABV) for the Australian Business Volunteers & Nauru Chamber of Commerce (NCC) – Phase 2 Partnership: Private Sector Road Map Implementation and Micro, Small, and Medium Enterprises (MSME) capability development. During financial year 2020-21, the NCC and ABV worked in partnership to develop the Private Sector Development Road Map, aligned with Nauru's National Sustainable Development Strategy. NCC and ABV's partnership will now focus on implementing the Road Map, focusing on MSME capability development as well as overall coordination support of Road Map activities and NCC strategic business planning.

### GENERAL BUDGET SUPPORT

Taiwan's contribution comprises **AUD \$14.3 million** (USD \$10.35 million) in direct Budget Support for mutually agreed purposes as per the Taiwan MOU Financial Assistance to Nauru. This Budget Support is reflected in the GoN Budget as cash. Additional funding for post-COVID economic recovery has been included. An annual contribution by Taiwan (ROC) to the Nauru Intergenerational Trust Fund of **AUD \$1.4 million** (USD \$1 million) is also reflected in the bilateral funding.

### TAIWAN TECHNICAL MISSION

Aid In-kind support through the technical mission is mostly directed toward improving household agriculture through training and provision of seedlings, reversing the NCD trend and visiting medical specialists. In FY 2022-23, this is valued at **AUD \$1.4 million** (USD \$993,087).

### COMMUNITY WELLNESS CENTRES

Discussions are currently underway regarding Taiwanese support for the building of Community Wellness Centres at Denig, Yaren and Anibare. Taiwan's contribution is estimated at \$900,000 AUD this financial year.

### SOLAR POWER PANELS

Taiwan supports Nauru's efforts to reduce reliance on fossil fuels through a solar panels project valued at **AUD \$552,105** (USD \$400,000) for the Civic Centre in FY 2022-23.

### SCHOLARSHIPS

Scholarships for secondary students to study in Taiwan are also valued at **AUD \$455,487** (USD \$330,000) for the coming fiscal year.

### ICT EQUIPMENT FOR CENPAC

Taiwan will provide AUD \$248,227 to assist CENPAC in purchasing much needed resources for the betterment of internet coverage provision for the people of Nauru.

Resources include:

- 3x 50m communication flight towers
- 2 Fibre Optic Cable Splicer

- 15 Fibre Optic Transceivers
- 10 Cisco Port Switches with accessories

This equipment will enable CENPAC to:

- Deliver significant improvement in broadband service quality (full internet coverage)
  - Address the lack of high-speed broadband, particularly outside of metropolitan areas (Ijuw District), and
  - Reshape the telecommunication sector.

## UN PACIFIC STRATEGY OUTCOME 1 - CLIMATE CHANGE, DISASTER RESILIENCE AND ENVIRONMENTAL PROTECTION

## SUPPORTING MAINSTREAMED ACHIEVEMENT OF ROADMAP TARGETS ON ENERGY IN NAURU (SMARTEN)

The objective of the SMARTEN project is to enable the increased applications of feasible renewable energy and energy efficiency technologies for supporting socio-economic development in Nauru in accordance with the country's energy roadmap targets. A total of **AUD \$1.4 million** (USD \$1 million) is earmarked to support the piloting of demonstration projects (hybrid and other energy efficient technologies), as well as technical training and workshops.

## RESILIENT HEALTH SYSTEMS BY THE WORLD HEALTH ORGANISATION (WHO)

The WHO will support resilience-building efforts for health systems by strengthening environmentally sustainable and climate-change resilient facilities, especially through WASH. A total of **\$28,986** (USD \$21,000) has been earmarked to support the initiative.

## UN ENVIRONMENT PROGRAM (UNEP) ECOSYSTEM RESTORATION AND SUSTAINABLE LAND MANAGEMENT

The UNEP will support Ecosystem Restoration and Sustainable Land Management to improve livelihoods and protection of biodiversity, development of an implementation approach for Hydrochlorofluorocarbon (HCFC) phase-out management and regulations to ban the import of HCFC-based equipment. A total of **AUD \$636,395** (USD \$461,068) has been earmarked to support these activities.

### UN PACIFIC STRATEGY OUTCOME 2 - GENDER EQUALITY

#### UNITED NATIONS CHILDREN FUND (UNICEF) – STRENGTHENING OF INSTITUTIONAL FRAMEWORKS TO PROTECT CHILDREN FROM ABUSE

UNICEF will undertake the following activities:

- Strengthening of institutional frameworks to protect children from abuse, neglect and exploitation
- Capacity building to the Social Welfare Sector in child protection prevention and response services
- Identification, treatment and reporting of children at risk and victims of abuse by health services
- Prevention and response to violence in schools and identification and reporting of abuse happening outside schools, and the
- Strengthening of knowledge, skills and attitudes of caregivers to protect children, and of children and adolescents to protect themselves and each other.

The WASDA-Child Protection Division, Ministry of Health and Medical Services and the Department of Education are the main Implementing Partners.

The total budget under this Outcome is **AUD \$167,012** (USD \$121,000).

### UN PACIFIC STRATEGY OUTCOME 3 - SUSTAINABLE AND INCLUSIVE ECONOMIC EMPOWERMENT

#### FAO - STRENGTHENING NATIONAL COORDINATION AND PLANNING FOR FOOD SECURITY AND NUTRITION

The project will support the development of policies that will help to strengthen the national coordination and planning mechanisms for food and nutrition security as well as offering training sessions to stakeholders. A total of **AUD \$69,013** (USD \$50,000) has been earmarked to support the initiative.

#### UNITED NATIONS EDUCATIONAL, SCIENTIFIC AND CULTURAL ORGANIZATION (UNESCO) - SOCIAL INCLUSION & COMMUNITY WELL BEING

The project will support initiatives that will:

- Identify, safeguard and promote living heritage
  - Support the strengthening of preparedness, mitigation and response to emergencies affecting culture
  - Help to protect, conserve and manage natural and cultural heritage through the implementation of the 1972 Convention Concerning the Protection of the World Cultural and Natural Heritage, and
  - Help to promote, monitor and measure the contribution of culture to the implementation of the 2030 Agenda for Sustainable Development.

A total of **\$5,714** (USD \$4,140) has been earmarked to support the initiatives.

#### **UN PACIFIC STRATEGY OUTCOME 4 - EQUITABLE BASIC SERVICES**

UNICEF/UNDP/WHO/UNFPA - IMPROVING AND STRENGTHENING OF HEALTH SYSTEMS

- UNITED NATIONS CHILDREN FUND (UNICEF)

Initiatives will focus on the following:

- Enhancing national capacities to strengthen quality health and nutrition policy and legislation including COVID19 vaccination
- Strengthening of health system capacities to deliver quality health and nutrition practices including COVID19 vaccination, and
- Increasing caregivers' knowledge and skills to adopt recommended health and nutrition care practices and increasing knowledge, positive attitude and demand for COVID-19 Vaccine.

A total of **AUD \$283,538** (USD \$205,423) has been budgeted for these initiatives.

- UNITED NATIONS DEVELOPMENT PROGRAM (UNDP) - TB AND HIV CASE MANAGEMENT

The initiative will support detection, prevention, treatment & care efforts as well as strengthening community systems, health management and information systems, financial management systems and human resources for health. Assistance will also be provided for mitigation of TB/HIV. A total of **AUD \$112,636** (USD \$81,605) has been earmarked for this program.

- WORLD HEALTH ORGANISATION (WHO)

WHO will provide:

- technical support to implement the Western Pacific Regional Framework to End TB 2021 -2030
- strengthening NCD prevention and care services for NCD management focusing on life course approach including healthy ageing
- providing technical support to achieve and maintain routine immunization coverage targets, community engagement and demand for vaccination, and
- strengthening systems and advocacy to awareness to prevent and address Anti-Microbial Resistance.

A total of **AUD \$110,421** (USD \$80,000) has been budgeted for these WHO programs.

- UNITED NATIONS POPULATION FUND (UNFPA)

The UNFPA will be strengthening access to quality integrated sexual and reproductive health services for women, adolescents and youth, across the development humanitarian nexus. A total of **AUD \$36,715** (USD \$26,600) has been budgeted for this initiative.

## UNICEF/UNESCO - IMPROVING AND STRENGTHENING OF EDUCATION SYSTEMS

- UNICEF

UNICEF will provide support to:

- improve access to early learning (ECD)
- build capacity to identify and respond to learning needs of children not attending school and/or who are at risk of dropping out, and
- develop regional goods and services in education in line with the Pacific Regional Education Framework to accelerate achievement towards UN Sustainable Development Goal 4 (Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all).

A total of **AUD \$20,478** (USD \$14,836) has been budgeted to support these initiatives.

- UNESCO

UNESCO will support the following:

- capacity building on Education for Sustainable Development (ESD) and Global Citizenship Education (GCED) and integration in curriculum and teacher training
- provision of Technical assistance and regional knowledge and experience sharing in Greening TVET;
- development of regional teacher training resources for multimedia and blended teaching and learning and ensuring multi-sensory approach inclusive of children with disability/learning difficulties, and
- resilient education systems through:
  - o Pacific Heads of Education Systems (PHES)
  - o knowledge sharing, and
  - o South-South collaboration to promote gender equality and inclusion in education, including equitable use of ICT in education.

A total of **AUD \$13,456** (USD \$9,749) has been confirmed. UNESCO may mobilise additional funds of **USD \$84,779** to make sure that the planned activities are completed – however, as this funding is not confirmed, it is not reflected in the development projections this financial year. If funding is secured, it will be reflected in the mid-year development fund report for FY 2022-23.

## **UN PACIFIC STRATEGY OUTCOME 5 - GOVERNANCE AND COMMUNITY ENGAGEMENT**

### UNICEF - MICS SURVEY SUPPORT

UNICEF will be supporting the evidence generation and data support for children and women. UNICEF will be working with the Nauru Statistics Office and SPC as implementing partners. A total of **AUD \$226,363** (USD \$164,000) has been budgeted.

### UNDP - NAURU ACCOUNTABLE AND INCLUSIVE GOVERNANCE (NAIG)

The UNDP is supporting the Nauru Electoral Commission and the Parliament of Nauru to strengthen institutional capacities. Support for the Parliament has been focused on the implementation of the Parliamentary Services Act while support to NEC is on civic education, electoral legal framework and

enhancing women's participation and inclusive electoral processes. **AUD \$1.6 million** (USD \$1.2 million) is earmarked for this financial period.

**UN PACIFIC STRATEGY OUTCOME 6 - HUMAN RIGHTS**

UNICEF has budgeted a total of **AUD \$55,210** (USD \$40,000) to support Convention on the Rights of the Child reporting processes. The UN Office of the High Commissioner for Refugees and the UNDP will also facilitate inclusive dialogues and decision-making in Nauruan communities, to strengthen social cohesion post-COVID-19. A total of **AUD \$141,666** (USD \$102,637) has been budgeted for this initiative.
