SUPPLEMENTARY APPROPRIATION No.4 2021-22

OVERVIEW

Supplementary Appropriation Bill (No.4) 2021-22 recognises additional Government revenue of \$10.1 million, and \$10.1 million in expenditure, with a small surplus balance of \$47 thousand.

This will bring total expected revenue for 2021-22 to \$338.3 million, and \$338 million is appropriated for expenditure, leaving a surplus balance for the year of \$0.3 million.

This Bill reflects updated revenue and expenditure estimates to take account of:

- Taxation revenue as a result of the 6-month extension of the Regional Processing Centre agreement with Australia from 31 December 2021 to 30 June 2022 not accounted for in the last supplementary
- Government decisions taken since the last supplementary budget was brought down

The full Parliament budget of \$1.5 million is to be transferred to Head 16 Finance Other to recognise its status as an autonomous Parliamentary Services independent of the other branches of the Government.

Parliament operates as a standalone unit consistent with its constitutional autonomy and funding will be through block grant from Department of Finance. In accordance with Parliamentary Service Act 2020, the Clerk shall provide quarterly financial reports to the Secretary for Finance on the expenditure of the Office for the purposes of accountability and financial planning.

\$3.4 million is provided to Sunco to partly fund conversion of the current passenger aircraft VH-XNU into a freighter aircraft, bringing the total freighter fleets to three. It is envisaged that having three freighter aircrafts will improve the reliability of services to Nauru and position Nauru Airline Corporation as the operator of the aircraft to secure full-time commercial charter contracts (Non-Brisbane - Nauru services) ensuring higher profits for the business in the long term.

The total work is estimated at \$5.6 million and the provision in this supplementary will enable Sunco to meet the deposit requirement of AEI Miami and part of the conversion costs. Advance payment of deposit will guarantee a slot in February 2023 for conversion works to commence. AEI Miami is a reputable company and they have carried out the first two conversions on NAC fleet. The balance of the conversion program cost will be settled in the new financial year.

- \$1.5 million is allocated as grant provision to Parliament offset by a reduction of the same amount from the Parliamentary Head 06.
- \$0.5 million is allocated to the Fiscal Cash Buffer to meet urgent and unavoidable expenditure measures that may arise for the remainder of the year, particularly relating to international travel and procurement.
