Mrs Griffin advised the Committee of the appointment of Ambassador Lan as the new ROC-Taiwan representative, replacing Ambassador Chow.

Ms Gillard advised the Committee of the appointment of Mr Henley as the new GOA representative, replacing Ms Stratton and noted Ms Slade was attending the meeting as his alternate. Ms Slade passed on Mr Henley's apologies for being unable to attend.

Mr Petersen welcomed the new Committee members and alternates and encouraged them to raise any queries throughout the meeting.

## 1. Approval of 27 May 2023 Meeting Minutes confirmed.

<u>Action Item</u>: BDO to collate remaining information to include in the 2023 Annual Report for presentation at the next meeting.

<u>Decision:</u> The Committee endorsed the information included in Mr Hutton's Monitoring Paper.
