PART I: EXECUTIVE SUMMARY

The Development Fund Annual Projections have been prepared as a separate budget document following the enactment of the *Development Fund Act 2011*. The Development Fund was established for the purpose of facilitating the funding of development projects.

After consultation with the donors and development partners, the Government of Nauru anticipates that the Total Development Fund for FY 2025-26 is **\$157.7m**.

From this support, Australia and China have committed a total of **\$50m** towards Budget Support directly. This will be accounted for by the Treasury Division through the Budget Paper.

Partners have indicated that a total worth of **\$107.7m** support will be provided to Nauru as "In-Kind" support. These are in the form of contributions, consultancy, workshops, scholarships, materials and equipment. A prominent example of an in-kind support would be the scholarships provided by Australia and New Zealand for tertiary studies.

There is no cash-funded support projected for FY 2025-26. This is the most liquid form of support for line agencies. **\$4.1m** in cash-funding will be carried over from FY 2024-25.

Total Expenditure is projected to be 100% of balance carried over from FY 2024-25, and is estimated to be **\$4.1m**.

PART II: DEVELOPMENT FUND ANNUAL PROJECTIONS

This document complies with Section 6 of the *Development Fund Act 2011*, which requires the Minister for Finance to table development fund projections in Parliament, consisting of anticipated development income and expenditure for the next financial year.

OVERVIEW

The GON projects that there will be no receipt of **Cash-Funded** support. The carried amount from FY 2024-25 was determined at **\$4.1m**. Therefore, it is anticipated that the entire sum of \$4.1m should be expended by the end of the financial year. This money is received in cash to the Republic, and paid directly into Development Fund accounts.

Additional assistance is also provided in the form of "In-Kind" support for projects that are funded by development partners for the benefit of Nauru. These Aid-In-Kind amounts are not paid into the Development Fund.

It is estimated that this in-kind assistance is valued at approximately **\$107.7m** for FY 2025-26. An example of Aid In-Kind support from donors is the cost of consultants or advisers currently working in Nauru that are paid for directly by donors. The projected development assistance from Nauru's major donors for FY 2025-26 is depicted in Table 2.2 below. It is anticipated that all projected funds will be expended in the financial year.



There is no commitment for Cash funded Support for development in the financial year 2025-26. Support in the form of Aid in-kind has increased by \$16m.


CASH FUNDING FY 2020-21 TO FY 2025-26

CHART 2.1: CASH-FUNDED PROJECTION: FY 2020-21 TO FY 2025-26




The trend of direct cash projections over the last four financial years is depicted in Chart 2.1. Cash-Funded support for this financial year has completely decreased by \$1.7m in FY 2024-25. This has become an expected trend as partners began providing more Aid in-kind support, for instance, consultants, plants & equipment, trainings, etc.

The People's Republic of China (China) began supporting Nauru in FY 2024-25 with initial funding of **\$15.1m**. In the FY 2025-26, support has been projected to increase to **\$46.1m**.

Comparing the past 4 years, Australia has increased its support by more than 70% at \$44.9m.

Support received from Japan has significantly increased through the periods. Compared to FY 2021-22, Japan's support upped by approximately **130%** at **\$31.2m**. These are carried out under the Economic & Social Development Program (ESDP).

ADB's support this financial year is set at **\$18.9m** for three major development projects. Support from UN is projected at **\$11.9m**, an increase by **\$6.4m**

New Zealand have maintained a consistent amount of support through the periods. For FY 2025-26, support has increased by **\$2.8m**, focused mainly on Climate.



As Tables 2.5 and 2.6, and Charts 2.4 and 2.5 illustrate, the Infrastructure Sector receives the most funding in FY 2025-26, at \$57.9m. This is an increase of \$12.7m from last year's total of \$45.2m.

The Social & Community Sector projects to receive support worth **\$45.2m**. This has also increased by **\$11.8m**, mainly in areas such as Sports, Health and Education.


Support for the Economic Sector is expected to amount \$38.6m, a \$20.7m increase from the previous financial year.

Finally, the Cross-Cutting Sector receives the smallest amount of funding this financial year, with **\$16m** in support, an increase of **\$4.1m**.

SDG ANALYSIS


Charts 2.7 below shows the breakdown of FY 2025-26 development funding across the 17 UN Sustainable Development Goals.

The SDG with the highest level of funding in FY 2025-26 is SDG 3 "Ensure healthy lives and promote well-being for all at all ages", allocated 29% of Nauru's funding envelope.

SDG 2 "End hunger, achieve food security and improved nutrition and promote sustainable agriculture" received the least funding.

SDG 14 "Conserve and sustainably use the oceans, seas and marine resources for sustainable development" received no funding this financial year.

For the fiscal year 2025-26, the Asian Development Bank (ADB) is expected to disburse approximately USD 10.8 m (AUD 13.5 m) of in-kind support for three major development projects.

SUSTAINABLE AND CLIMATE RESILIENT CONNECTIVITY PROJECT

The Sustainable and Climate Resilient Connectivity Project, also known as the Port Project, was approved by ADB in August 2018 with a budget of USD 62.28 m (AUD 91.56 m), including co-financing from the Australian Government and the Green Climate Fund. In 2022, ADB provided additional funding of USD 15 m (AUD 23 m) to cover the temporary accommodation expenses associated with the relocation program for the Port Project.

For the fiscal year 2025-26, the remaining major works for this project include the installation of permanent protective measures for the Northern Container Yard revetment using specially designed rock bags, as well as achieving the target depth of the wharf basin. An estimated USD 8.4 m (AUD \$13.5 m) will be disbursed to cover construction costs and supervision fees for the project.

SOLAR POWER DEVELOPMENT PROJECT

The Solar Power Development Project encompasses the installation of a 6MW solar energy farm, alongside institutional capacity development initiatives to support sustainable operations. This project, approved in September 2019, has a total budget of USD 22 m (AUD 32.34 m) and is intended to deliver positive impacts for Nauru households.

In the fiscal year 2025-26, following the commissioning of the solar grid into the Nauru Utility Corporation's (NUC) national power system, an estimated USD 800,000 will be disbursed to the Joint Venture contractor and the Project Implementation Consultant for their services.

NAURU SUSTAINABLE URBAN DEVELOPMENT PROJECT (NSUDP)

The Nauru Sustainable Urban Development Project (NSUDP) is designed to improve Nauru's water supply, sanitation, and solid waste management systems. Approved in November 2024, the initiative carries a total funding of USD 37.5 m and is supported by the Project Readiness Financing (PRF) fund of USD 5 m, initiated in August 2021 during the project's design phase.

In FY 2025-26, the project will transition into the next phase, which includes hiring a Contract Supervising Consultant (CSC) and initiating a tender process to select a contractor for civil construction works under the USD 37.5 m urban development initiative. For this fiscal year, ADB anticipates disbursing USD 1.2 m in in-kind assistance through the PRF to support the existing project management team overseeing the design phase. Additionally, approximately USD 370,000 will be disbursed for initial implementation activities. Once contracts are finalized for the CSC and civil works contractor, disbursement levels for the NSUDP are projected to increase significantly.

IMPROVING FISCAL SUSTAINABILITY PROGRAM - SUB-PROGRAM 2

Additionally, ADB will allocate an estimated USD 1 m (AUD 1.6 m) for technical assistance aimed at supporting the Improving Fiscal Sustainability Program. This initiative focuses on strengthening state-owned enterprises (SOEs), enhancing social protection frameworks, promoting gender equality, and advancing efforts within the climate change sector.

NAURU- AUSTRALIA TREATY

Under the Nauru-Australia Treaty (NAT) signed in December 2024, Australia will provide \$100 million over five years in direct budget support to further strengthen Nauru's economic security and resilience. This support will assist to give the Government of Nauru fiscal certainty to invest in Nauru's future, including by making deeper and long-term investments in education, health and social services to enhance the well-being of the Nauruan people.

Through the Treaty, Australia will ensure Nauru does not risk being de-banked again. The Commonwealth Bank of Australia commenced banking operations in Nauru in August 2025.

Australia and Nauru will expand and deepen our security cooperation, committing to consult on developments that threaten our sovereignty, peace or stability. Australia commits to maintaining its standing as Nauru's primary security partner through \$40 million in new investments that will support Nauru's policing and security needs. This includes Australian support for police and broader national

security, capital infrastructure, training, equipment, recruitment and retention.

AUSTRALIA'S DEVELOPMENT PROGRAM IN NAURU

Under the Australia-Nauru Aid Partnership Arrangement, Australia and Nauru are working together to improve economic growth opportunities and improve development outcomes for Nauruans. The development program works to strengthen health, climate-sensitive infrastructure, education and economic governance outcomes for Nauru.

Health

Australia has partnered with Nauru to support health outcomes for over 25 years. Post are streamlining multiple health work streams and advisers into one consolidated program. The new Rana Tsimorum (2025-2035) investment is a whole-of-health program that works with the Government of Nauru to ensure that Nauru's health system is better able to respond to health threats and effectively deliver inclusive quality health services and population-level interventions for the people of Nauru. This program is made up of three components: health system strengthening, health service delivery, and inclusive health. It will continue existing successful workstreams including visits by surgical teams and veterinarians, inline advisers and health information improvements; while also opening up new work streams in priority areas identified by Nauru¹.

Climate-sensitive infrastructure

Australia's infrastructure development program in Nauru is in transition from multiple separate infrastructure projects into one consolidated program, learning lessons to improve practice and local delivery. Current support includes projects to upgrade Nauru's port and airport runway. Further projects will support Government of Nauru's priorities for infrastructure as per the Nauru Sustainable Infrastructure Strategy with an investment design to be developed from 2025.

Education

The \$20m Nauru Education Program provides support to Nauru's education system and is aligned with Government of Nauru's policy frameworks and systems. The program funds advisers and education activities, as well as administration of the Australia Awards scholarships in Nauru. The program is continuing to 2027 under a managing contractor (TetraTech), with plans for a limited tender approach for the next phase from 2027.

Nauru usually receives 10-20 places across the Australia Awards and Australia Awards Pacific annually depending on funding and applicants.

Australia also supports direct-funding agreements (DFAs) to the Government of Nauru to fund education activities in Nauru including scholarships for Nauruans to study in Brisbane high schools, teacher salaries, licensing fees enabling Nauruan schools to offer the Queensland Certificate of Education, and partnership between the Nauru Department of Education and Queensland TAFE to deliver vocational education.

Economic Governance

Australia is assisting the Government of Nauru to strengthen and implement a robust public financial

management system. The Nauru Accountable and Inclusive Governance Project (NAIG) strengthens governance intuitions, including in the justice sector, Parliament, the Nauru Electoral Commission and Civil Society Organisations. Australian Business Volunteers works with the Nauru Chamber of Commerce to develop Nauru's private sector and regional business linkages. To support long-term economic resilience, Australia partners with Nauru and New Zealand to contribute annually to the Nauru Intergenerational Trust Fund. A planned community grants program will provide economic opportunities to local communities.

Program Support

The Nauru Support Services (NSS) agreement with a managing contractor (Palladium) provides corporate and logistical support to the Australian High Commission and development program. It is currently funded from both administered ODA and departmental funding. It facilitates access to a range of services including property, maintenance, security, vehicles, and amenities.

The People's Republic of China will provide \$30m in direct Budget Support to address government priorities.

In addition, the PRC and Nauru are collaboratively developing several projects valued at \$16.1m, in the following areas:

INFRASTRUCTURE

PRC is working with the Department of Sports on supporting the infrastructure needed for the Micronesian Games in 2026, including the National Stadium for track and field events, a sports hall, high-performance centre and all related equipment.

CAPACITY BUILDING

The People's Republic of China will continue to support medical team visits to the Ministry of Health and Medical Services.

Tertiary scholarships for Nauruan students will be provided in FY 2025-26. In addition, China will continue to provide technical training in various areas for government officials to support their capacity development.

Support to the Department of Environment and Agriculture through South-South Co-operation mechanisms is also being explored.

THE ECONOMIC & SOCIAL DEVELOPMENT PROGRAM (ESDP)

The Economic & Social Development Program (ESDP) is a type of assistance intended to support Nauru by promoting its economic and social development efforts inclusive of poverty reduction. ESDP provides foreign currency for import of goods as Aid In-Kind. There is a total of four ESDP projects that are ongoing:

- Provision of Port Equipment valued with a total grant funding of 600M JPY (\$6.7m AUD)
- Provision of heavy machinery for the Nauru Rehabilitation Corporation total grant funding of 200M JPY (\$2.2 m AUD)
- Provision of East Micronesia Undersea Cable for Nauru Fibre Corporation total grant funding of 1.561B JPY (\$17.4 m USD)
- Provision of Patrol Boat to Nauru Police Force total grant funding of 440M JPY (\$4.9m AUD).

NAURU INTERGENERATIONAL TRUST FUND

New Zealand will make an annual contribution of \$1m NZD (\$917,431 AUD) to the Nauru Intergenerational Trust fund in June, as a member of the Trust Fund Committee.

SCHOLARSHIPS

Nauru is included in the Manaaki New Zealand Scholarship Programme and is eligible for tertiary awards, short-term cohort courses, and individual short-term training. The total amount forecast across tertiary awards and short-term cohort courses FY 2025-26 is unclear, but is likely to be around the same amount as FY 2024-2025 being: \$802,156 NZD (\$735,923 AUD). Additionally, there is budget available to Nauru scholars to be drawn down for individual short-term training awards.

NAURU EDUCATION SUPPORT 2024-2027

New Zealand announced during Deputy Prime Minister Peters' visit to Nauru in July 2024 that New Zealand would be providing Nauru with \$5 million NZD (\$4,618,269 AUD) in education support from 2024-2027: Focus on resilience and education in Nauru. This activity is still in design in consultation with the Nauru Department of Education. Support for FY 2025-26 is currently forecasted as \$1.1 million NZD (\$1,009,923 AUD).

NAURU ENERGY EFFICIENCY - NAURU ENERGY EFFICIENCY ON THE DEMAND SIDE (NEEDS) PROJECT

The Nauru Energy Efficiency on the Demand Side (NEEDS) project Grant Funding Agreement (GFA) was signed in December 2020, and is funded by the Ministry of Foreign Affairs and Trade (MFAT) of the Government of New Zealand. The aim is to support the achievement of the 30% energy efficiency target set in the Nauru Energy Road Map (NERM). The project is now in the implementation phase.

NEEDS total project funding for FY 2025-26 will be \$71,284 NZD (\$65,398 AUD).

REGIONAL PROGRAMME SUPPORT

New Zealand also supports Nauru's development through various regional programmes, totalling approximately \$2,220,230 NZD (\$2,036,908 AUD). A non-exhaustive list comprising of only forecasted payments over NZ\$100,000 is provided below.

Strengthening Water Resilience - NZ\$427,283

This activity invests in water security. Access to an adequate, reliable, and safe supply of water underpins almost every aspect of development. Reduced availability of water affects lives and livelihoods, thereby limiting almost every other element of social and economic advancement.

This work is based on the investment plans developed by each country facilitated by SPC (the Pacific Community) within a community of practice framework.

Country Flexible Finance - NZ\$678,333

This modality involves capacity support and capability building interventions in 15 Pacific countries, in disciplines related to Public Financial Management and Public Investment Management for Climate-related priorities. Areas supported include public financial management systems, support to strengthen national planning, sectoral planning, investment planning, investment proposals, and supplementation of specialist skills (e.g. procurement, monitoring, and reporting) to address capacity constraints.

Pacific AML Strengthening - NZ\$101,600

This funding supports one-on-one mentoring during operational activities, the creation of knowledge repositories and reference materials, and the use of interactive training. These activities are intended to have longer term benefits that have traditionally been achieved through one-off training exercises.

Pacific Qualifications Recognition - NZ\$159,769

NZQA and EQAP are working together to deliver the Pacific Qualifications Recognition project. This fiveyear Activity seeks to:

- build Pacific Island countries' ownership, trust,
- support of the Pacific Qualifications Framework (PQF), and
- increase consistency of Pacific qualification recognition and quality assurance processes across the Pacific region by strengthening the PQF and Pacific national qualifications systems.

Pacific Parliamentary Strengthening - NZ\$131,894

This activity supports parliamentary strengthening in the Pacific region through delivering a package of technical assistance and support to Pacific parliaments.

Supporting Partner Anti-Corruption Commitments – NZ\$110,000

This activity supports the work of the United Nations Office on Drugs and Crime (UNODC) and Transparency International (TI) in the Pacific. UNODC will support countries to meet their commitments to the Teieniwa Vision and UN Convention against Corruption, while TI's anti-corruption programme is to promote and empower civil society and citizen engagement in reducing corruption.

Pacific Audit Support - NZ\$195,300

Funding will be provided to the Pacific Association of Supreme Audit Institutions (PASAI) to support Pacific audit institutions perform their core functions in line with PASAI's 2024-34 Strategy. The support is available from 2024-29.

Funding is also provided to the New Zealand Controller and Auditor-General (CAG) to support the PASAI Secretariat.

Pacific Public Sector Strengthening - NZ\$130,605

The Public Service Fale is a five-year Pacific public service strengthening programme, managed by a Wellington-based specialist team embedded in the New Zealand Public Service Commission. The programme works with Pacific Island countries to actively support public sector reform initiatives, develop Pacific-specific solutions and support Pacific Public Service Commissions to share knowledge and experience across the region.

Pacific Justice Sector - NZ\$172,731

Support areas under this funding include:

- access to justice,
- case management and efficiency,
- reporting and transparency,
- capacity and access development (including targeted support for women in the judiciary), and
- human rights.

Investing in NCDs in the Pacific - NZ\$112,715

The focus areas for this investment are:

- tobacco control,
- treatment of NCDs and their risk factors in primary care health facilities,
- data collection on NCDs and their risk factors,
- capability building for NCD policy development, and
- capability building for NCD monitoring and evaluation.

\$40,323 will be provided to help children, adolescents and communities in the Pacific, particularly those living in risk-prone areas, are more prepared for emergencies and are supported during emergencies.

\$8,065 will be provided to help the Government and their partners have enhanced capacities to plan for and coordinate quality, climate-resilient WASH response emergency preparedness.

World Health Organization (WHO)

\$41,339 will be provided to assist health facilities to detect and respond to climate related disease at all

times.

United Nations Educational, Scientific and Cultural Organisation (UNESCO)

\$20,709 will be provided for targeted capacity building for key stakeholders working with World Heritage sites, Intangible Cultural Heritage and Museum collections. The workplan will also aim to promote the formal inclusion of culture in emergency management systems in selected countries.

United Nations Development Programme (UNDP)

\$1,612,903 will be provided for the Supporting Mainstreamed Achievement of Roadmap Targets on Energy in Nauru (SMARTEN) project, in accordance with the country's energy roadmap targets. The funding will support increased applications of feasible renewable energy and energy efficiency technologies for supporting socio-economic development in Nauru.

PEOPLE PILLAR: ENSURING PROSPERITY, INCLUSIVITY AND WELL-BEING FOR ALL

United Nations Development Programme (UNDP)

\$6,451,613 will be provided for the Multi-Country Western Pacific Integrated HIV/tuberculosis (TB) Programme, supported by the Global Fund, to strengthen control of HIV and TB in 11 Pacific island countries: Cook Islands, Federated States of Micronesia, Kiribati, Nauru, Niue, Palau, Republic of the Marshall Islands, Samoa, Tonga, Tuvalu and Vanuatu. The program will focus on reducing the spread of HIV/TB and mucolipidosis in 11 Pacific-island countries through prevention, diagnoses treatment and care.

United Nations Population Fund (UNFPA)

\$179,192 has been provided to strengthen pre- and in-service capacity of midwifery and Sexual, Reproductive, Maternal, Newborn and Adolescent Health workforce in services including Emergency Obstetric and Newborn Care, management of sexually transmitted infections (STIs) and cervical cancer screening.

\$43,279 has been earmarked to scale up adolescents and youth access to quality assured youth-friendly and disability-inclusive sexual and reproductive health services and information.

\$179,192 will be provided to coordinate with governments, implementing partners, UN agencies, regional entities and international financial institutions to strengthen policy formulation and implementation, domestic financing, accountability and coordination mechanisms, for integration of sexual and reproductive health, gender-based violence and women's and youth empowerment into national socio-economic development plans and budgets.

\$136,116 has been provided to align family life education to the international technical guidance on sexuality education (ITGSE) and operationalize it.

\$93,485 is allocated for:

- advocacy with and capacity development of religious, cultural institutions and opinion leaders
- capacities of National Human Rights Institutions and human rights mechanisms
- integration of sexual and reproductive health and reproductive rights and gender-based

- violence prevention into gender equality and women and youth empowerment programmes/initiatives, and
- strengthening partnerships with and capacities of regional, national and local feminist and other women's rights-based organizations.

\$15,484 will be provided for:

- advocacy and support for implementation of human rights commitments related to the International Conference on Population and Development (ICPD)
- men and boys engagement for positive masculinities, and
- strategic and behavioural change communications and public/media campaigns.

United Nations Educational, Scientific and Cultural Organisation (UNESCO)

\$6,452 will be provided for knowledge sharing, south-to-south collaboration, and capacity support through Pacific Heads of Education Systems (PHES).

\$4,839 has been allocated for increased capacity in integrating and expanding Education for Sustainable Development and Global Citizenship Education.

United Nations Children's Fund (UNICEF)

\$135,484 has been allocated to strengthen capacities to generate, analyse and use data to reduce multidimensional child poverty.

\$80,645 has been earmarked for strengthening Nauru's capacity to deliver child-sensitive and shock-responsive social protection.

\$8,065 has been provided to develop climate-resilient and sustainable, safely managed WASH services and adoption of safe hygiene practices. \$8,065 has also been allocated to improve the coverage, quality and resilience of WASH services in schools and healthcare facilities.

United Nations Conference on Trade and Development (UNCTAD)

\$76,194 will be provided for:

- a gap analysis on Customs-related WTO Trade Facilitation Agreement (TFA), FTA measures, including iEPA
- comprehensive legal revisions in each PACP to align with WTO TF Priority Measures (Category C notifications)
- analysis of the business process re-engineering for WTO TFA in priority areas; EPA plus other Free Trade Agreements (FTAs) compliance activities
- Trade Facilitation Assessment Framework including Time Release Studies (TRS)

\$39,863 will be provided for ASYCUDA World (AW) in the Customs Administrations, and ASYCUDA functional and technical trainings, mobilization seminars etc.

PROSPERITY PILLAR: PROMOTING INCLUSIVE AND SUSTAINABLE ECONOMIC GROWTH

Food and Agriculture Organization of the United Nations (FAO)

The FAO will provide \$132,627 for boosted sustainable production systems and \$378,676 for improved agri-processing and market and trade efficiencies.

United Nations Children's Fund (UNICEF)

\$135,484 is allocated to strengthen capacities to generate, analyse and use data to reduce multidimensional child poverty.

United Nations Conference on Trade and Development (UNCTAD)

\$76,194 will be provided for:

- a gap analysis on Customs-related WTO Trade Facilitation Agreement (TFA), FTA measures, including iEPA

PEACE PILLAR: ENSURING PEACE HUMAN RIGHTS, GENDER EQUALITY AND PARTICIPATION

The Nauru Accountable and Inclusive Governance (NAIG) project

The Nauru Accountable and Inclusive Governance (NAIG) Project aims to support key democratic institutions in Nauru which are responsible for ensuring effective, inclusive and accountable political governance. The project aims to strengthen the capacity of the Nauru Parliament to effectively undertake its legislative, oversight and representative roles.

United Nations Office for High Commissioner for Human Rights (UNOHCHR)

The UNOHCR will provide support towards duty bearers' increased commitment to human rights standards outlined in international human rights treaties and mechanisms, and engagement with these human rights mechanisms and processes throughout the implementation and reporting cycle.

United Nations Office on Drugs and Crime (UNODC)

\$8,065 will be provided for technical support to law enforcement and border agencies to fight transnational organised crime including maritime crime. This includes a threat assessment of transnational organised crime and human trafficking, and capacity building of law enforcement and

border agencies to detect, investigate and prosecute transnational organised crimes including maritime crime.

\$64,516 will also be provided for building the capacity of national agencies and authorities to prevent, raise awareness of, detect, investigate and prosecute corruption.

United Nations Population Fund (UNFPA)

\$7,741 will be provided to support the capacities of National Human Rights Institutions and human rights mechanisms, and \$11,623 for evidence generation, analysis and measurement of social and gender norms changes.
